<b>Category Three: Contracts</b>	<b>Section 4.15 – 4.16</b>	I have a registerable interest where I (or a firm in which I am a partner, or an undertaking in which I am a director or in which I have shares of a value as described in paragraph 4.20 of the Code) have made a contract with DGC:  a) under which goods or services are to be provided, or works are to be executed; and b) which has not been fully discharged.  I will register a description of the contract, including its duration, but excluding the value.	None

<b>Category Four: Election Expenses</b>	<b>Section 4.17</b>	If I have been elected to DGC, then I will register a description of, and statement of, any assistance towards election expenses relating to election to my public body.	None
<b>Category Five: Houses, Land and Buildings</b>	<b>Section 4.18 – 4.19</b>	I have a registerable interest where I own or have any other right or interest in houses, land and buildings, which may be significant to, of relevance to, or bear upon, the work and operation of DGC.  I accept that, when deciding whether or not I need to register any interest I have in houses, land or buildings, <i>the test to be applied is whether a member of the public, with knowledge of the relevant facts, would reasonably regard the interest as being so significant that it could potentially affect my responsibilities to DGC and to the public, or could influence my actions, speeches or decision-making.</i>	None
